1. Of the body of a child up to the age of 18 years inclusive		No Charge
Interment of the body of a child up to 18 years of age is free into a single depth grave. Where interments are required at double depth or below then single interment charges for over 18's will apply.

	Double depth	£965 not including grave digging.

In respect of items 2 – 6 above there will be a 50% discount on the prices stated in the following circumstances:		
(i)	If the deceased had been resident in the Parish of Stoke Golding for a minimum period of 12 months within the period of 10 years prior to the date of death.	
(ii)	In respect of the advance purchase of grave plots, the purchaser is registered on the electoral role as being a resident within the Parish of Stoke Golding at the date of the application to purchase.	
(iii)	If, at the discretion of Stoke Golding Parish Council, there is a proven long-term, continued association of the deceased with the village of Stoke Golding.	
In respect of items 2 – 6 above there will be a 25% discount on the prices stated in the following circumstances:		
(iv)	If the deceased had been resident in Dadlington in the Parish of Sutton Cheney for a minimum period of 12 months within the period of 10 years prior to the date of death.	
(v)	In respect of the advance purchase of grave plots, the purchaser is registered on the electoral role as being a resident within Dadlington in the Parish of Sutton Cheney at the date of the application to purchase.

Details of charges for items not shown on this list may be obtained from the Cemetery Administrator.

Record Searches are made free of charge. Hand written copies of record entries are available free of charge. Where available Saturday and Sunday interment work may attract double fees. * Kerbs are not normally allowed in the cemetery but occasionally they may be allowed with special permission of the Parish Council in Hinckley Road Cemetery only, if for example there is already a kerbed grave next to the one for intended interment.

A copy of the Stoke Golding Parish Council Cemetery Byelaws and Guidelines should be given out to families so that they are aware of restrictions before they agree to burial.
