

## STOKE GOLDING NEIGHBOURHOOD PLAN ADVISORY COMMITTEE MEETING – MINUTES (DRAFT)

Held on Monday September 24th, 2018 7.00pm at the Methodist Hall

23/1 Apologies from Roy Mitchell (Chair)

23/2 No declarations of interest.

23/3 Previous minutes and notes were confirmed.

23/4 There were no matters arising.

23/5 Roy Mitchell (Chair) had resigned and the committee held an election for Chair and Vice Chair.

23/6 Jim Hope was elected Chair. Sarah Beale Vice Chair.

23/7 Sarah Beale was elected Vice Chair.

22/8 a) There is a need to recruit new members and non-members to the advisory committee and Jim Hope will initiate and manage a campaign.

b) A discussion took place on how to progress the completion of the Neighborhood Plan. The aim is to complete by 2019. Committee members to investigate support offered from:

Rural Community Council - Jim Hope to investigate

Neighborhood Plan Champion, David Statham (Blably Neighborhood Plan) - Jim Hope to investigate

Kirkwells Consultants - Rob Gaskin to investigate

HBBC - information required on date of publication of Strategic and Economic Housing and Land Availability Allocation (SEHLAA) document. This has been subject to delay and it is required for completion of the Neighborhood Plan - Jim Hope follow up.

23/9 It was agreed that the frequency of meetings will increase and take place every fortnight at the Methodist Church Hall on Monday evening at 7pm.

23/10 Residents voiced their concern over the barriers created by the delay in publication of SEHLAA document, to progress the completion of the Neighborhood Plan. It was suggested that The Advisory Committee progress all other areas of the plan that are complete and unaffected by the SEHLAA.

23/11 The chairman advised that the public exhibition/presentation planned by the agent for the developers of the site behind Station Road, due to take place in September, had been postponed by the agent. The Advisory Committee objected to the agent's wording of their publicity material and statement that the scheme was being "promoted" in conjunction with The Neighborhood Plan. Sarah Beale advised that this subject will be an agenda item on the forthcoming Parish Council meeting on Wednesday 3rd October and a report will be issued to The Advisory Committee.

23/12 There were no items to be brought to the public's attention.

23/13 Date of next meeting: Wednesday 8<sup>th</sup> October at 7pm in The Methodist Church Hall.
